1. Introduction

In 2019 Federal State Budgetary Institution «National Accreditation Agency» (hereinafter referred to as the Agency or NAA) carried out its activities in accordance with the Federal Laws of the Russian Federation, normative and legal acts of the Government of the Russian Federation, the Ministry of Science and Higher Education of the Russian Federation (hereinafter - the Ministry of Education of RF), and the Federal Service for Supervision in Education and Science (hereinafter - Rosobrnadzor) and its Statue.

The report provides statistical information on the work results for 2019, as well as the analysis of the results and defines the main tasks and directions of NAA's activity for the near future.

2. Normative and legal basis of the state accreditation procedure of educational activities for educational organizations

2.1. Overview of changes and additions related to the procedure for conducting state accreditation of educational activities, and other relevant issues in the field of education in connection with amendments to various normative and legal acts

Decree of the Government of the Russian Federation of August 15, 2019 No. 1052 "On Amending the Regulation on State Accreditation of Educational Activities" in August 2019 amended the Regulation on State Accreditation of Educational Activities, approved by Decree of the Government of the Russian Federation of November 18, 2013 No. 1039. It was established that an application of the educational organization should include confirmation of reliability of information contained in the documents and materials published on the organization's official website. The list of documents attached by the organization to the application is approved, including:

- an educational organization has the right to indicate a link to the placement of documents and materials (including educational standards) on the organization's website (with the electronic signature of the head) without providing them in paper copy;

- a list of documents attached to the application for state accreditation of private educational organizations founded by religious organizations is specified;

- educational organizations establishing educational standards independently are granted the right not to submit these standards to the application for state accreditation in case the standards are available on-line.

The member of the accreditation body indicated in the executive directive shall monitor expert panel's activity and is responsible for reviewing an experts' conclusion based on the external review results. A 5-year duration of certification of experts and expert organizations has been introduced. Furthermore, the educational organization has the right (within 5 days from the date of receipt of information on identified inconsistencies in content and (or) the quality of students' learning outcomes to the requirements of federal state educational standards) to take measures to eliminate the identified inconsistencies and submit documents confirming the elimination to the expert panel group, including an electronic form of the document signed by electronic signature of the head of the organization. The procedure for recording data on independent quality assessment of students' learning outcomes, submitted to the accreditation body. Independent quality assessment of students' learning outcomes should be carried out within 3 years before the educational organization submits an application for state accreditation. Independent quality assessment should be performed by legal entities meeting the following requirements:

- use evaluation tools that have received recommendations from the federal educational and methodical association in accordance with modal provisions on educational and methodical associations in education system and (or) agreed upon by the council for professional qualifications (if any);

- relate to all-Russian or other associations of employers, associations (unions) or other organizations representing and (or) uniting the professional community in the professional field;

- involve experts with qualifications corresponding to the levels of education as well as professions, specialties and fields of training for which this assessment is carried out.

The Order of Rosobrnadzor dated November 29, 2019 No. 1628 "On approval of applications for state accreditation of educational activities, on renewal of a state accreditation certificate of educational activities and / or its annexes (appendices), on issuing a temporary state accreditation certificate of educational activities, on issuing a duplicate of a state accreditation certificate of educational activities and / or annexes (appendices) to it, a form of information on the implementation of basic study programs declared for state accreditation of educational activities, and requirements for their completion and execution".

The features of establishing compliance between specialties assigned in different years are explained by a letter of the Ministry of Education and Science of Russia dated 02.22.2019 No. MH-2.1 / 729 "On the ARCSE (All-Russian Classifier of Specialties in Education) and lists of specialties and fields of training". This document provides, in accordance with Federal Law dated December 29, 2012 No. 273- Φ 3 "On Education in the Russian Federation", lists of professions, specialties and fields of training indicating qualifications assigned to relevant professions, specialties and fields of training. The procedure for these lists formation is approved by the federal executive body

performing the functions of developing state policy and legal regulation in the field of education (by the Ministry of Education and Science of Russia). The Ministry of Education and Science of RF approving the new lists of professions may determine the compliance of certain professions (indicated in these lists) with the professions, specialties and fields of training specified in previous lists. The first indicators of correspondence between old and new Russian higher education specialties, between the All-Russian classifier of specialties in education (ARCSE) and the list of fields of training and specialties of higher professional education were approved by the Ministry of Education of the Russian Federation in 2000. Therefore, it is not possible to establish the correspondence between the lists currently in force and with the lists valid until 2000, due to the absence of normative legal acts establishing such conformity. At the same time, in the regulatory legal documents determining the lists of higher education specialties and being valid until 2000, there is information allowing to establish the existence of a particular specialty.

Letter of the Russian Ministry of Education and Science dated February 14, 2019 No. MH-21/818A presents the review of changes in the regulatory legal framework for the organization and implementation of educational activities on study programs of higher education, as well as on the application of certain norms of federal state educational standards of higher education

According to the Law on Education, universities develop study programs in accordance with the Federal State Educational Standard (FSES). The programs include basic (compulsory) and the variable parts. The Ministry of Education and Science of Russia explains that FSES of higher education establishes the mandatory development in the framework of the base part of Block 1 "Disciplines (modules)" only in relation to the disciplines (modules) listed in clauses 6.4-6.5 of the standard. The set of disciplines (modules) related to the basic (compulsory) part of the study program is determined by the educational organization independently in the amount established by the specific FSES of higher education. Clarifications are given on assigning various competency groups to the basic and variable parts of study program and on creating an electronic information and educational environment, in particular, establishing criteria for educational process, which is within the competence of the educational organization and is regulated by its local act.

Letter of the Ministry of Education and Science of RF dated February 14, 2019 No. MH-21/819 clarified the inclusion of certain disciplines in study programs of higher education, namely that disciplines (modules) and internship ensuring the formation of professional competencies (established by an approximate basic study program as recommended (if available)), as well as professional competencies (determined by the educational organization independently), can be included in both the compulsory and the optional parts of study program.

The letter of the Ministry of Education and Science of RF dated January 21, 2019 No. MH-2.1 / 222 outlines admission rules implemented by educational organizations to the first year students from January 1, 2019 for a number of specialties only in accordance with the FSES, updated on the basis of professional standards. Students enrolled in training earlier than the specified date continue their training in accordance with the previous Federal State Educational Standards (the norm also applies to students enrolled after interruption in education or transferring from another educational organization). At the same time, organizations are entitled to provide training and the educational process for specialties not having updated FSES is carried out in accordance with previous FSES. The educational organization should take into account the approximate basic study programs entered in the special register no later than the year preceding the year in which admission is carried out (i.e., when enrolling for training in 2019 - programs entered in the register in 2018).

2.2. Participation in the development of normative and legal acts

In order to update the current legislation in the field of education in 2019, the Agency actively participated in the development of draft normative and legal acts regulating the activities of Rosobrnadzor regarding the state accreditation of educational activities.

The proposals for amendments and additions to the Decrees of the Government of the Russian Federation of November 18, 2013 No. 1039 "On state accreditation of educational activities" were developed and prepared. The Government of the Russian Federation adopted Resolution No. 1052 of August 15, 2019 "On Amending the Regulation on State Accreditation of Educational Activities"; **the main principles** of the document are:

- an increase in the share of documents used during accreditation posted on the website of an educational organization;

- reduction of the data when submitting an application for state accreditation;

- using of the results of an independent quality assessment;

- specification of qualification requirements for experts and expert organizations, establishment of responsibility of experts and expert organizations;

- the possibility for educational organization to address identified inconsistencies with FSES requirements revealed during state accreditation.

The entry into force of this document entailed the need for a comprehensive amendment of regulatory legal acts on state accreditation of educational activities. Thus, with the adoption of Decree of the Government of the Russian Federation of August 15, 2019 No. 1052 "On Amending the Regulation on State Accreditation of Educational Activities", the order of Rosobrnadzor dated November 29, 2019 No. 1628 "On approval of applications for state accreditation of educational activities, on renewal of a state accreditation certificate and / or its annexes (appendixes), on the

issue of a temporary certificate of state accreditation, on the issuance of a duplicate of a certificate on state accreditation and / or its annexes (appendixes), forms of information on the implementation of basic study programs declared for state accreditation of educational activities, and requirements for their completion and execution" was approved

Furthermore, the following proposals were sent to prepare draft normative legal acts on amendments to the orders of Rosobrnadzor:

- "On approval of qualification requirements for experts and expert organizations, the procedure for their certification, including the procedure for maintaining the register of experts and expert organizations, the procedure for involving, selecting experts and expert organizations for external review";

- "On approval of documents and materials necessary for conducting external review of the basic study programs declared for state accreditation of educational activities."

The normative legal acts regulating the issues of state accreditation of educational activities should be supplemented with the possibility of conducting state accreditation of educational activities in electronic form (as a whole or partially), as well as the availability of expert panel activity in the case when the external review is carried out remotely using IT-technologies. In this regard, the proposals to the draft order "The working procedure of experts and (or) representatives of expert organizations included in the expert panel during external review on the basic study programs declared for state accreditation of educational activities" were sent. A new form of conducting external review in electronic form will reduce the burden on organizations involved in educational activities. It will be possible to save financial resources by reducing the cost of travel and accommodation for members of expert panels, which are necessary in the case of external review with a site-visit to establish compliance with FSES, and will also allow educational organizations to reduce financial and time costs for submitting documents, considering amounts and territorial remoteness.

In addition, the Agency participated in the development of a new model of state accreditation of educational activities and initiated proposals to improve this procedure.

3. The main directions of NAA's activity

The Agency was created for assisting Rosobrnadzor in executing its powers, including state accreditation of educational activities of organizations as well as the formation and maintenance of information resources.

In accordance with its Statute the subject of the Agency's activity is to provide organizational, technical, information, methodological and analytical support related to the execution of Rosobrnadzor's powers.

According to the subject of the main activities within the subsidy allocated to the Agency for reimbursement of legal costs associated with the provision of state services (works) under the state task, the Agency performs the following activities:

organizational, technical, information and analytical support for the peer review procedure to confirm the compliance of content and quality of students' training on basic study programs declared for state accreditation with the federal state educational standards;

organizational, technical, information and analytical support of the procedure of certification of experts and (or) expert organizations for conducting peer review;

organizational and technical support for the collection, processing and storage of accountability and (or) other documented information in relation to educational organizations involved in licensing and state accreditation procedures of educational activities;

organizational, technical, information and analytical support of Rosobrnadzor's activities in conducting supervision (control) in the sphere of education in relation to educational organizations on accredited study programs;

preparation of draft methodological and other documents on the analysis of content and quality of students' training in organizations involved in educational activities;

monitoring research in the education system of the Russian Federation to ensure the powers executed by Rosobrnadzor;

organizational support for assisting Rosobrnadzor in executing its powers for electronic interaction with government bodies;

organizational and technical support related to the execution of Rosobrnadzor powers in formation and maintenance of information resources.

3.1. Organizational, technical and information-analytical support for peer review procedure

The Agency supports the state accreditation procedure through the implementation of three main stages:

I. Analysis of documents submitted by educational organizations and data input into the Information system of state accreditation;

II. Organization and support of external review;

III. Analysis of the results of external review and preparation of documents to be delivered to the accreditation body for making accreditation decision.

I. Analysis of the documents submitted by educational organizations and data input into the information system of state accreditation

The Agency analyzes the documents submitted by educational and scientific organizations in paper and electronic form for state accreditation of educational activities / for renewal of the state accreditation certificate, as well as data input into the information system of state accreditation (hereinafter referred to as IS SA); posts the documents attached to the application on the IS SA; verifies documents and based on the results prepares draft notifications of receipt of the application and the attached documents for consideration on the merits or their non-compliance.

Check-in of the correctness of filling and completeness of the submitted documents is carried out in accordance with the Regulations on State Accreditation of Educational Activities, approved by the Government of the Russian Federation dated November 18, 2013 No. 1039 (hereinafter referred to as the Regulations) and the Administrative Regulations on the Provision of State Services on State Accreditation of Educational Institutions and Scientific Organizations by the Federal Service for Supervision in Education and Science.

In 2019, 787 applications were submitted from educational and scientific organizations. Compared to 2018, the number of applications has not changed (2018 - 780 applications), of which:

- 708 applications (90%) - for full accreditation and renewal of the state accreditation certificate in connection with the accreditation of previously not accredited study programs;

- 79 applications (10%) - for renewal in connection with the change of the name, location, change of the codes of IGSFT, reorganization.

Moreover, 388 applications were submitted in electronic form (about 49% of the total number of applications submitted), which is 1.3 times more than in 2018 and 5 times more than in 2017.

This dynamic demonstrates the active use of the electronic form for submitting applications for state accreditation, which ensured by information and methodological support of the state accreditation procedure in the context of its conversion to electronic form.

A total of 73 applications were withdrawn, which is 9% of the total number of applications submitted in 2019.

The main reasons for withdrawing of applications prior to the receipt of documents for consideration on the merits are: the decision of the organization to apply for state accreditation of educational activities, or submission of documents in violation of the established requirements for documents necessary for the provision of public services.





Fig. 1. Draft notifications prepared in 2019 according to the applications, submitted for state accreditation and accreditation of study programs

According to applications submitted for state accreditation and renewal of state accreditation certificates in connection with the accreditation of previously not accredited study programs, 1072 draft notifications were prepared, of which: 589 (55%) draft notifications of acceptance of the

application and the attached documents for consideration on the merits; 74 (7%) of draft notifications of refusal to accept documents for examination on the merits, 409 (38%) of draft notifications of non-compliance (Fig. 1.).




Fig. 2. Draft notifications prepared according to applications for renewal of state accreditation certificate in 2019

Based on applications for renewal of certificates of state accreditation, 107 draft notifications were prepared, of which 66 (62%) draft notifications of receipt of the application and attached documents for consideration on the merits; 14 (13%) draft notifications of refusal to accept documents for examination on the merits; 27 (25%) draft notifications of non-compliance (Fig. 2.).

The main reasons for the refusal to accept documents for consideration on the merits are the availability of an unfulfilled prescriptive order or order to suspend, deprive or refuse of state accreditation, as well as the availability of detected nonconformities.

The analysis showed that draft discrepancy notifications of average make up more than 30%. This demonstrates the lack of personnel experience when working with the relevant documents and the lack of knowledge of the established requirements related to the submission of documents for the provision of public services.

The main nonconformities of the submitted documents with the established requirements are: Incorrect name of the procedure.

The application is filled out in violation of the established form, approved by the Order of the Ministry of Education and Science of Russia dated March 18, 2014 № 193:

- the absence or inconsistency of data on the details of the current state accreditation certificate;

- lack of information in the line: "according to the following basic study programs";

- lack of information about the license for the right to work using information constituting a state secret (if necessary);

- lack of a seal of an educational institution;

- inconsistency of data on the organization location, name, as well as the MSRN (Main State Registration Number), CR (Code of Reason), TIN (Tax Identification Number) of the organization with the data specified in the system of interagency electronic interaction;

- incorrect presentation of information regarding basic study programs:

- inconsistency of the codes / titles of IGSFT, codes / names of the basic study programs with the lists of professions, specialties and areas of training, approved by the regulatory documents of the Ministry of Education and Science of Russia;

- inconsistency of the name of the education level of the basic study program with the levels specified in regulatory documents (Article 10 of the Federal Law of December 29, 2012 No. 273- Φ 3 "On Education in the Russian Federation");

- discrepancy between the dates of training time specified in the FSES and declared in the application;

- incomplete or incorrect information on basic study programs: not all accredited basic study programs are taken into account or are indicated in accordance with the attached documents (including when submitting an application for renewal of the state accreditation certificate);

- the lack of data on study programs included in an integrated group of professions, specialties and fields of vocational training, for which the organization is deprived of state accreditation (in case of certificate renewal);

- incorrect indication of the reason for renewal of state accreditation certificate;

- the absence of the reason for changing the organization's location, name or reorganization, etc. (in case of certificate renewal).

3. The documents attached to the application do not meet the established requirements:

- inconsistency of information on study program delivery with the approved form (Order of the Ministry of Education and Science of the Russian Federation of July 6, 2015 No. 667 "On approval of the data forms on delivering study programs declared for state accreditation "):

- absence of the name of the head of the organization;

- discrepancy of the declared level of education;

- discrepancy of the date of filling out with the date specified in the application;

- lack of information about the contingent of students;

- lack of the seal on the inventory of documents submitted by an educational institution or certification of an inventory by a person who is not the head of the organization

When filling out and submitting an application in electronic form, the following observations were noted:

- the application and the attached documents are certified by the electronic signature of a person who is not the head of the organization;

- incorrect format of the archive with documents (cannot be decoded);

- inconsistency of the data in the attached application file and the data specified in the personal account of the organization carrying out educational activities.

The analysis of the documents reveals the following observations:

- the license to carry out educational activities has not been brought into compliance with the established lists of professions, specialties and fields of training (according to part 9 of article 108 of the Federal Law dated December 29, 2012 № 273 of the Federal Law "On Education in the Russian Federation");

- invalid information on the availability of a license to carry out educational activities: there is no license for educational activities;

no changes were made to the license on the organization's location in accordance with the USRLE (the Unified State Register of Legal Entities) /SMEV (Interagency Electronic Interaction System);

- lack of information on a wide-profile stadium's address in the license;

- no changes were made to the state accreditation certificate on the organization's location in accordance with the USRLE (the Unified State Register of Legal Entities) /SMEV (Interagency Electronic Interaction System).

In order to minimize errors and deviations made by educational organizations, when submitting an application for state accreditation with the required package of documents, in 2019, 12 training events were held in the format of practice-oriented seminars (see section 4 of this Report).

II. Organization of the external review

The planning of external reviews implemented by the Agency is carried out taking into account the specifics feathers of educational organizations. A specialist (task manager) from the Agency's staff is assigned to each educational organization for organizational and methodological support of the expert panel's work.

The invitations and expert consents to participate in external the review are generated automatically. It makes it possible to optimize the process of preparing for external review.

Agency specialists carried out continuous monitoring of data on the location and name of the educational organization in accordance with the data contained in the USRLE (the Unified State Register of Legal Entities) (in 2019, 2060 requests were prepared and sent using the IEIS (Interagency Electronic Interaction System)).

In 2019, 705 external reviews were supported, in respect of 10466 basic study programs delivered by educational organizations with participation of 3509 experts on the basis of executive directives of Rosobrnadzor.

The number of contracts concluded with experts during the reporting period amounted to 3274.

In order to conduct external reviews without a site-visit the Agency prepared 226 requests to educational organizations in the reporting period (of which: 8 educational organizations were not reviewed) and received documents and materials on 565 basic study programs for conducting external review, as well as created the necessary conditions for the work of expert panels.

The Department for Organizational Support and Logistics received 563 sets of documents according to an inventory for the formation of accreditation cases.

In connection with the transfer of the state accreditation procedure into electronic form in 2019, in the framework of the experiment on testing the new technology, the Agency fully conducted 6 external reviews in electronic form.

According to the data contained in the integrated information system of licensing and accreditation, the number of experts owning an electronic signature (ES) is no more than 5%. Thus, the number of certified experts involved in the automated selection of experts by the presence / absence of ES and engaged in external reviews conducted in electronic form is reduced. Therefore, participation in the external reviews of individual experts may become irregular.

In 2019, the Agency's training seminars for experts and representatives of expert organizations were especially devoted to the issues of transferring state accreditation services into electronic form, including the need for an electronic signature for experts.

Certified experts who have the necessary qualifications in the field of study programs declared for state accreditation and certified expert organizations participated in external reviews.

In 2019, 1,783 applications from individuals were submitted for the establishment of an expert's powers. 5 application applications were accepted for termination of powers of an expert organization from legal entities: Association of Communities and Organizations whose activities are aimed at developing and implementing management methods and standards and assessing the quality of programs of Business and Management Education "National Accreditation Council of Business and Management Education"; All-Russian public organization «Russian Union of Youth».", Autonomous non-profit organization "Expert Centre for rating the quality and qualifications in legal studies established by Association of Lawyers of Russia"; All-Russian public-government enlightenment organization Russian "Znanie" society", "Agency for Quality Assurance in Higher Education and Career Development.

As part of the experts' certification procedure, the Agency prepared 11 meetings of the Accreditation Commission of the Federal Service for Supervision in Education and Science for certification of experts and expert organizations involved in external reviews of educational activities. The Accreditation Commission made the following decisions:

to establish the powers of an expert - 536 people .;

to refuse to establish the powers of an expert - 267 people;

to remove the powers of an expert - 4 people .;

to establish the powers of 4 expert organizations, except for the Agency for Monitoring the Quality of Education and Career Development.

As of December 31, 2019, the number of certified experts from educational organizations amounts to 1842 people. (Table 1.). In addition, the number of foreign experts amounts 8 people (Armenia - 3 people, Kazakhstan - 5 people).

As of December 31, 2019, the number of certified experts by federal districts / regions of the Russian Federation is presented in Appendix 1.

The main reasons for experts' refusal to participate in external reviews of basic study programs are:

- business need (performance of the rector's duties; election of the rector, dean, head of the department; participation in conferences, competitions, etc.; employment in the educational process, etc. during external review; preparation for state accreditation of its own educational organization);

- failure by the management of the educational organization;

- vacation at the time of external review;
- inconvenient transport logistics;
- temporary disability;

- family circumstances (lack of available funds for the flight, state of health of the family members, etc.).

According to the results of the analysis conducted in 2019, the most numerous is the composition of certified experts involved in state accreditation carried out in relation to study programs in the following integrated groups of specialties and fields of training: 09.00.00 Informatics and computer engineering; 38.00.00 Economics and management; 40.00.00 Jurisprudence; 44.00.00 Education and pedagogical sciences.

The composition of certified experts in integrated groups of specialties and fields of training 55.00.00 Screen arts, 58.00.00 Oriental studies and African studies, 08.00.00 Construction equipment and technologies; 13.00.00 Power and heat; 24.00.00 Aircraft and rocket and space technology; 28.00.00 Nanotechnology and nanomaterials; 07.00.00 Architecture, 17.00.00 Weapons and weapon systems is considered to be insufficient.

III. Analysis of external review results and preparation of documents to be delivered to Rosobrnadzor for making an accreditation decision

According to the results of the conducted external reviews, 10909 external review reports and expert conclusions, based on the results of external reviews on 10224 basic study programs, were submitted to Rosobrnadzor. Compared to the results of 2018, the volume of work increased by 17% (in 2018, 9088 reports and conclusions on 8465 study programs were analyzed and submitted to Rosobrnadzor).

By Rosobrnadzor's decision, 5769 integrated groups of specialties and fields of training were accredited, and state accreditation was denied for 151 integrated groups of specialties and fields of training in relation to the levels of vocational education.

630 orders on state accreditation of educational activities / refusal of state accreditation were issued, including:

- 605 orders on state accreditation of educational activities (including 43 orders on refusal of state accreditation with respect to certain levels of vocational education in certain integrated groups of professions, specialties and fields of training (hereinafter referred to as the partial refusal order);

- 25 orders on the refusal of state accreditation of educational activities.

In total, in 2019, the accreditation body denied state accreditation (as a whole or partly) to 68 educational organizations, which is 59% less compared to 2018.

The table below shows the total number of educational organizations that in 2017-2019 were refused of state accreditation activities (as a whole or partially) in relation to the levels of vocational education by integrated groups of professions, specialties, and fields of training — IGPSFT (Table 2.).

The list of educational organizations that in 2019 were denied state accreditation of educational activities (as a whole or partally) in relation to levels of vocational education under by IGPSFT, is presented in Appendix 2.

During the reporting period, 294 state accreditation certificates and 611 annexes to them were prepared, 37 certificates and 46 annexes were reissued, as well as 37 annexes to current certificates of state accreditation.

An analysis of documents and materials based on the results of external reviews allows for the conclusion that the greatest number of incompliances with the requirements of federal state educational standards was identified in terms of the training content and the conditions for the basic study programs' delivery, as well as the quality of students' training:

a) non-compliances of the training content

1. The disciplines of the variable part of the basic study programs of higher education do not determine the orientation (profile) of the programs, do not provide for the formation of professional competencies corresponding to the types of professional activity the programs oriented to.

2. Inconsistencies in the general workload of disciplines (modules) provided in the working programs of disciplines (modules) and specified in basic study programs' curricula.

b) inconsistencies regarding the conditions for the basic study programs' delivery.

1. General management of the scientific content of Master's programs is carried out by the academic staff who do not have annual publications on the results of research (creative) activities in leading domestic and (or) foreign peer-reviewed scientific journals and publications.

2. The managers of the scientific content of Master's programs and academic advisors of postgraduate students do not have the approbation of the results of research (creative) activities at national and international conferences.

3. The electronic and information educational environment does not contain a record of the educational process progress, the results of intermediate certification and the results of study program acquisition, there is no access to publications of electronic library systems and electronic educational resources indicated in the working programs.

c) non-compliances of the quality of students' training

1. The discrepancy between the results of the basic study program acquisition and the required results of mastering the BSP.

2. The discrepancy between the expected results of the basic study program acquisition (competencies to be formed) in the working programs of disciplines (modules) and programs of practices and the assessed competences in the funds of assessment tools for these disciplines (modules) and practices.

3.2. Information and analytical support of state accreditation procedure carried out by the Agency's branch in Yoshkar-Ola

In 2019, the Agency's branch in Yoshkar-Ola carried out work on the preparation of information and analytical materials based on the data about the delivery of study programs declared for state accreditation and information posted on the official websites of educational organizations.

During the reporting period, an analysis of 10323 data about the delivery of study programs was conducted, on which information and analytical materials were prepared.

In 2019, the NAA's branch carried out a number of additional works to the planned activity.

Information and analytical materials have been prepared (basic information, a list of licensed and accredited IGPSFT, information on monitoring process implemented by the Ministry of Education and Science of Russia, data on control and supervisory measures in relation to educational organizations, information on accreditation procedures in relation to educational organizations, the students' contingent, data on academic staff, material technical base) for 24 educational organizations. The generalized informational and analytical materials were prepared on educational organizations delivering study programs on Theology.

Information on the availability of a license for educational activities in the Unified State Register of Legal Entities for 2400 educational organizations was verified.

A list of new study programs licensed in 2018 has been compiled.

3.3. Organizational and technical support for the formation and maintenance of information resources related to the exercise of powers of Rosobrnadzor

In 2019, as part of the work of technical support and functioning of information systems, continuous work was provided for:

- information system of state accreditation (IS SA);

- information system of licensing educational activities (IS LEA);

- register of organizations engaged in educational activities on state-accredited study programs (SIS Registry);

- module of the Automated System for Supporting the Process of Distribution of Admission Quotas for Citizens Enrolled at the Expense of the Federal Budget and the Formation of State Tasks for Training Personnel in State Educational Institutions of Higher Vocational Education (AS AQ and ST).

During 2019, the Agency ensured the formation and maintenance of information systems databases; transfer of the information on accreditation of study programs of educational organizations to the consolidated register of organizations conducting educational activities on stateaccredited study programs; transfer of the information on licenses of educational organizations to the register of licenses for educational activities.

In order to display complete and up-dated information in information systems, the Agency staff carries out monitoring of the entered data, as well as compares the input information and data in the system of interagency cooperation.

The agency provides system administration:

- access for registered users;

- access to the Personal Account of the expert and educational organization;

- processing requests received from users about errors in the work of information systems;

- advising users on working with systems;

- elimination of systems failures.

In response to requests from the founder of the Agency for the reporting period, 212 reports were prepared on the procedures for state accreditation and licensing of educational activities. 1028 certificates and 1135 annexes were transferred to the SIS «Registry».

Consulting technical support was provided for users of IS SA in the amount of 1310 appeals. 144 requests were processed from users regarding the correction of errors in the database.

Measures were taken for complex protection of the restricted access information, including personal data:

- extension / purchase of Dr.Web anti-virus software;

renewal / purchase of the technical support certificate for the information security product
 Hardware-software complex encryption "Continent", vGate R2 Standard, Net Studio 8, and XSpider
 7.8 software.

4. Information support for experts and expert organizations involved in conducting external reviews of study programs implemented in organizations involved in educational activities and representatives of educational organizations

In 2019 Agency's staff conducted 21 training events, including 5 webinars and 16 seminars in accordance with the schedule of training seminars and webinars agreed with Rosobrnadzor,

- 12 practice-oriented seminars in Moscow;

- 4 retreats in St. Petersburg, Ufa, Makhachkala, Sochi.

In 2019 the Agency (in addition to the training activities planned in the schedule) implemented training for representatives of educational and scientific organizations on the further vocational training programs (further training programs). In accordance with the license for educational activities (issue 77Л01 No. 0010527, registration number No. 039647 dated 09/21/2018), 11 events were carried out:

- "The use of EIEI (Electronic Information and Educational Environment), ELS (E-library System) and ICT (Information and Communication Technologies) tools in the implementation of study programs in accordance with the requirements of the Federal State Educational Standard" (Moscow, Barnaul);

- "Development and implementation of the basic study program in accordance with the requirements of the Federal State Educational Standard" (Moscow, Chelyabinsk, Samara, Tyumen);

- "Training of experts candidates for state accreditation of educational activities" (Moscow, Belgorod);

- "Personnel conditions for a basic study program delivery" (Makhachkala);

- "State regulation of educational activities" (Moscow).



At the training events, much attention was paid to the main changes in the legislation in the field of education and in the normative legal regulation of the procedure for state accreditation of educational activities, the basic requirements for the development of study programs of higher education, issues of improving the state accreditation procedure, including the terms of transitions in electronic form.

In total, 1736 people participated in the Agency's training events in 2019, including 157 people took part in in webinars, 862 people – in practice-oriented seminars and retreats, and 717 people – in the events for further training programs.

Weekly Agency's staff hold skype-meetings with experts involved in external reviews. The number of experts participating in 38 skype-meetings during the reporting period amounted to 2906 people. 7 seminars were organized for information support of experts and expert organizations, in which 230 people took part.

The feedback mechanism with participants in training events is actively used: according to the results of skype-meetings, an average of about 50 questions are received weekly, according to the

results of the conducted seminars (held at least 2 times a month) more than 100 participants' questions are answered by the Agency's staff.

A participants' survey of 2019 showed that the rate of compliance of the topics and content of the conducted training events with the participants' expectations is: 73% in full, 27% in part. The participants noted as the most relevant the following topics: "Changes in legislation support in state accreditation procedure", "Audit of study programs", "The modern tools for assessing the quality of educational activities; the basic requirements for internal quality assurance"; "The requirements for filling out an application for state accreditation and forms of information on the implementation of study programs declared for state accreditation of educational activities."

5. Agency's participation in seminars, meetings, forums, conferences

In 2019, Agency's staff took part in 35 events (seminars, forums, meetings, conferences, etc.) organized by federal executive authorities of the Russian Federation (Rosobrnadzor, The Federation Council, The Ministry of Science and Higher Education of the Russian Federation), HEIs, public (All-Russian Public Organization «Russian Union of Youth», The Medical League of Russia) and non-profit organizations (The Association of Classical Universities of Russia, The National Fund for Personal Development), expert organizations involved in conducting external review, etc.

The range of issues discussed at these events is quite wide: priority areas for the development of education in the Russian Federation, improvement of normative and legal framework in the field of education, new challenges and approaches to the quality of higher education, improving state accreditation of educational activities, etc.

The total number of participants in the events from the Agency's executive staff and employees was 18 people (29% of the Agency's main staff).

Information on the Agency's participation in seminars, meetings, forums, conferences is presented in Annex 3.

6. Project activities

In 2019, the Agency implemented two projects.

1. The project of the Federal Service of Supervision in Education and Science (Rosobrnadzor) "Updating methodological materials and conducting training events for experts and people applying for expert status as part of state accreditation of educational activities." Within the project, Agency's staff held 2 training events (organized on May 10, 2019 and August 10, 2019 in Moscow) to prepare candidates for experts and heads of expert panels involved in conducting state accreditation of educational activities under the topics: "Training seminar for people applying for the status of an expert for state accreditation of educational activities" and "Conducting external review within the framework of state accreditation of educational activities". 1368 people were trained during these events. Furthermore, targeted work was undertaken to improve the methodological support of expert activities on state accreditation.

2. The project of the Ministry of Science and Higher Education of the Russian Federation "Integrated expert assessment of Russian universities' potential for providing professional training in economy and social sphere for the Regions of the Russian Federation". As part of the project, Agency's staff held a seminar "Current challenges and results of conducting integrated assessment of universities' potential providing professional training for the basic sectors of the economy and social sphere of the Russian Federation". 106 people participat3ed in the event. (December 10, 2019, Moscow).

7. International activities

In 2019 the Agency participated in a number of events for studying international experience and for developing national system of quality assurance.

Information on Agency's participation in the international events is provided in the table below.

- improvement of work with experts and expert organizations (tightening the principles of selecting applicants for experts, experts' skills development, training of applicants for experts, information and consultation work with experts);

- transition of the state accreditation procedure of educational activities into electronic form, including a registry model for the provision of services;

- development of the Agency's international activities related to interaction with foreign and international organizations in the sphere of quality assurance of education;

- wide interaction with various structures of executive authorities, the academic, professional and expert communities on issues of external quality assurance;

- active participation in project activities;

- development of the motivational capacity of the Agency's staff, improvement of the Agency's organizational structure in accordance with its goals and objectives.
